Position Summary

Reporting to the Manager of Corporate and Academic Information Systems, the Senior IT Banner Systems Analyst will be a primary lead on multiple IT projects, and expected to guide programmer analysts in the area of academic, administrative and information systems applications development, technical writing, product upgrades, new releases and general IT systems maintenance to College standard. The incumbent will be involved and primarily responsible for all phases of the systems development life cycle where developing, testing and program maintenance is required to support the College Banner Enterprise Resource System. The incumbent will adhere to ITIL ITSM best practices and established project management methodologies.

Responsibilities

Systems Analysis

- Analyzes business requirements to identify the make rebuild or buy options that will guide development of the preferred solution
- Participates in all phases of product development and systems integration, including (but not limited to) feasibility studies, architecture design and validation
- Create inclusive and comprehensive solutions that comply with the needs of the business
- Develop and module test new and existing software programs as required for Banner ERP

Software Development

- Hands on software development, deployment and product integration
- Create best practice, policy and procedure technical documentation
- Provide hands on operational support
- Liaise between the business and service providers

Technical Advising and Consultation

Product support, systems monitoring and problem management of delivered systems and services to the College

Quality Assurance

- Unit and mock testing of applications, performance testing and benchmarking and thorough documentation

Research and Analysis

- Identify new releases and emerging technologies that may be used to estimate and guide the duration and effort required to manage patch, point and full product upgrades

- Three (3) year diploma / degree in Information Technology or Computer Sciences, which should include course in systems analysis or an equivalent combination of education and experience in Information Technology or Computer Science.
