The Department of Economics at Saint Mary's University invites applications for a tenure track appointment at the Assistant Professor rank. The position is open to any sub-field in economics, however there is a preference for **Applied Macroeconomics**, **Macroeconomic Theory and Econometrics**. Candidates with a demonstrated record in research and teaching in these fields are especially encouraged to apply. The successful candidate will have completed, or be near completion of, a PhD in economics, and have excellent qualifications for research and teaching in our graduate and undergraduate programs. Candidates must have a commitment to upholding the values of equity, diversity, and inclusion as it pertains to research activities, teaching and service. The appointment will commence July 1, 2023.
